The Software Product also includes any software updates, add-on components, stencils, templates, shapes, symbols, web services, documentation, training material, brochures and/or supplements that Trimble Solutions Sandvika AS may provide to You or make available to You, or that You obtain from the use of features or functionality of the Software Product, after the date you obtain your initial copy of the Software Product or you are provided access through internet the use of the services (whether by delivery of a CD or DVD or other media, permitting downloading from the Internet or a dedicated web site, or otherwise). By installing, copying, downloading, accessing or otherwise using the Software Product, or by signing this EULA, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install, access or use the Software Product; instead, you should return it to your place of purchase for a full refund.

SOFTWARE PRODUCT LICENSE

The Software Product and all its contents are protected by intellectual property laws and treaties. The Software Product is licensed, not sold.

- 1. GRANT OF LICENSE. This Section of the EULA describes Your general license rights to install and use the Software Product. It also describes a set of additional license rights. The license rights described in this Section are subject to all other terms and conditions of this EULA.
- 1.1 General License Grant to Install and Use Software Product. You may install and use one copy of the Software Product on a single computer, device, workstation, terminal, or other digital electronic or analog device ("Device"). You do not have the right to allow other people to access and use Your copy of the Software Product from Your Device unless You follow the restrictions described in the alternative license grant in the next paragraph. - 2. License system can be Named User or FLEXIm

- 4. Our web pages have details on the licensing part.

Upgrade from earlier versions

Novapoint 2020 is a new product, not an upgraded variant of earlier versions.

You may have other versions of Novapoint installed on the same client computer, but they shall never run at the same time. Such Side By Side installations makes it easier to gradually go from one version of Novapoint to the next version of Novapoint.

System requirements

Before you install Novapoint 2020 (ac18) on a stand-alone computer, make sure that your computer meets the minimum requirements. See the following table for hardware and software requirements. See also Autodesk requirements if you use AutoCAD with Novapoint 2020 (ac18).

Install Novapoint 2020 (ac18)

Prepare for installation

You can take several preparatory steps to ensure that your installation of Novapoint 2020 (ac18) is successful.

- 1. Make sure you have Administrator privileges to the local machine where you want to install Novapoint 2020 (ac18).
- 2. Update the local machine with the latest Windows updates.
- 3. Make sure all Windows updates are successfully (not failed).

- 4. Always do a restart before you do a major install. Windows may wait for a restart to finish previous installations and can block new installations.
- Optional install Autodesk application to use with Novapoint 2020 (ac18) and make sure this runs correct.
- 6. Close all running applications.
- 7. Downloaded the install image (ZIP-file) and extract all files and folders (unzip) for the installation to a local folder on your local machine.

Install Novapoint 2020 (ac18)

To install Novapoint 2020 (ac18) on a stand-alone computer

- 1. Run Setup.exe from the unzipped folder for the installation.
- 2. Select Install from the "Install" installation launcher.
- You must finish installation of prerequisites before you install Novapoint 2020 (ac18).
 Follow the instructions for the prerequisite dialog if it is started by Setup.exe.
 When the prerequisites are installed the installation of Novapoint 2020 (ac18) should start.
- 4. On the Welcome to the InstallShield for Novapoint 2020 (ac18) page, click Next.
- 5. Review the Novapoint 2020 (ac18) software license agreement. You must accept this agreement to complete the installation. To accept, click *I accept the terms in the license agreement*, and then click *Next*.
- 6. On the *Destination Folder* page choose *Next* to install to the default installation folder or choose *Change* to select other installation location.
- On the Ready to Install the Program page, click Install to begin the installation. If you want to review or change any of your installation settings, click Back. Click Cancel to exit the wizard.
- 8. Wait until the installation is completed.
- 9. When the installation is completed, the InstallShield Wizard Completed is displayed.
- 10. If the computer have a connection to the internet, check *Yes, check for program updates* (recommended).
- 11. Click Finish to close the Novapoint 2020 (ac18) InstallShield Wizard.
- 12. Update the PC with the latest Windows updates and restart the PC.
- 13. Install a license for Novapoint. See *How to license Novapoint* on the *Licensing Novapoint* page
- 14. Start Novapoint 2020 (ac18) and select the AutoCAD and configuration to use.
- 15. You may change settings later from the Startup Settings application.

If you prefer to avoid the first time startup dialog to pop up, these values have to be set.

Uninstall Novapoint 2020 (ac18)

Always uninstall Novapoint 2020 (ac18) using the uninstall feature in Add / Remove programs. To uninstall Novapoint 2020 (ac18).

- 1. On the Start menu, click Control Panel.
- 2. In the Control Panel, double-click Programs and Features
- 3. In the Uninstall or change a program window, select "Novapoint 2020 (ac18)" in the list, and then click Uninstall.
- 4. Follow the instructions.

Unattended installation

You may install Novapoint 2020 (ac18) from the command-line.

The "Novapoint 2020 (ac18).msi" file resides in the folder "Install\Novapoint" in the Novapoint 2020 (ac18) install image.

Downloaded image must be unzipped before you run Setup.exe or the MSI file.

Install running msiexec.exe from the command-line

The installation requires administrator privileges on the client computer.

[PATH to install files] in the section below refers to the path the installation can be found.

Syntax:

To install Novapoint using MSIEXEC.EXE use the following syntax: Msiexec /i "[PATH to install files]\Novapoint 2020 (ac18).msi" INSTALLDIR="C:\Program Files\Trimble\Novapoint\2020 (ac18)" /qb

Note: Installing using the MSI-file will not install the setup prerequisites included in Setup.exe. Install prerequisites one by one prior to the installation of Novapoint MSI-file.
